The first bidding for the 60 unit's Desktop computer was declared a failure by the Bids

		-		and Awards Committee. Since there were additional two(2) batches of desktop computers (30 and 80 units) to be procured, the Management decided to have these desktop computer procured through DBM-PS so that all procurement activities of computers will be coursed through the central procurement of DBM. Thus the PhilSCA BAC issued Resolution No. 202-A-2012 dated July 10, 2012 for the procurement of 60 units desktop computers through DBM-PS. The said project was consolidated and published by DBM-PS with PhilGEPS under Reference No. 2107639 and Public Bidding No. 13-011. The said transaction is still under bidding by the DBM-PS. It was the reason why the PhilGEPS posting was no longer reflected by the Bids and Awards Committee in the Certificate of Compliance for Item No. 3(60 units desktop computers) because this transaction will be posted anyway by the DBM-PS in the PhilGEPS when it will consolidate all procurement request for the three(3) batches of desktop computers. Thus it appeared in the Certificate of Compliance that there were three(3) batches of requests for the procurement of 60 units, 30 units and 80 units of desktop computers respectively.
