This Supplemental Bid Bulletin No. 1 dated October 10, 2022 is being issued to clarify, modify or amend items in the Bidding Documents.

The following items in the Bidding Documents for the Supply and Delivery of Various IT Equipment & Peripherals for All PhilSCA Campuses as discussed and agreed during the pre-bid conference held last October 4, 2022 are hereby revised/amended:

1. Invitation to Bid (ITB)

2. The Philippine State College of Aeronautics now invites bids for the above Procurement Project. Delivery of the Goods is required within ninety (90) days upon receipt of Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).	2. The Philippine State College of Aeronautics now invites bids for the above Procurement Project. Delivery of the Goods is required within One Hundred Twenty (120) days upon receipt of Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. 
5. Discussions during the pre-bid conference/additional information/reminders to the bidders:

- a. It was discussed that the delivery period was changed to One Hundred Twenty (120) days upon issuance of the NTP from originally ninety (90) days.
- b. It was discussed and made clear that the items to be repaired are those delivered items with defects due to the end-users' mishandling. Also, items to be replaced are those delivered items with manufacturer's defects or supplier's mishandling.
- c. It was also made clear to the bidders that **ALL** items under this project are to be delivered at the main campus, PhilSCA-Villamor Campus, Pasay City. Also, it was made clear that the winning supplier will take the responsibility to freight all items intended for PhilSCA-Medillin Campus to Cebu. The College will provide the complete list of items to the winning supplier all items to be freighted to PhilSCA-Medillin Campus, Cebu.
- d. It was mentioned that the supplier must have a repair center/station located within NCR and in Cebu.
- e. The BAC required the bidders for their Certificate of Authority to Resell.
- f. The BAC Secretariat reiterated the items enumerated in the checklist along with other requirements to be complied and submit by the bidder/s.

This Supplemental Bid Bulletin No. 1 shall form part of the Bid Documents. Any provision in the Bid Documents inconsistent herewith is hereby amended, modified, and superseded accordingly.
