6. Other Discussion

a. The BAC secretariat read and discussed important sections of the Bidding Documents. It was made clear that the procurement is one lot.

b. The following were reiterated:

- the delivery period is within one hundred twenty (120) days from the issuance of the NTP.
- all items are to be delivered in the main campus, PhilSCA-VAB, Pasay City
- no advance or partial will be allowed, payment will be processed upon full delivery of the items.
- the number of years required for the SLCC is within the last five (5) years prior to the date of submission of bids.


c. The submission and opening of bids were moved to 1:50 pm and 2:00 pm, respectively on March 9, 2023.
