Rebidding of the Procurement of Security Services of the Philippine State College of Aeronautics (All Campuses) for the Period of June to December 2023

This Supplemental Bid Bulletin No. 2 dated May 7, 2023 is being issued to clarify, modify or amend items in the Bidding Documents.

The following items in the Bidding Documents for the Rebidding of the Procurement of Security Services of the Philippine State College of Aeronautics (All Campuses) for the Period of June to December 2023as discussed and agreed during the pre-bid conference held last May 2, 2023 are hereby revised/amended:

Inclusion during the discussion.

During Saturdays, Sundays, and holidays (special or regular) only five (5) security personnel are required to be deployed in the Main Campus-Pasay City per shift.

1 shift = 6am to 6pm 2nd shift = 6 pm to 6 am

Consist of the Detachment Commander and four (4) security guards. 12 hrs/duty per guard

There must be at least one security personnel who is well trained in CCTV operation for VAB campus only.

- a) PhilSCA-Villamor Campus, Pasay City 20 = Security guards (8hrs duty/day)
- 1 = Detachment Commander (12 hrs duty/day)
- 1 = Shift-in- Charge (12 hrs duty/day)
- b) PhilSCA-FAB Campus, Lipa, Batangas City 2 = security guards (12 hrs duty/day)
- c) PhilSCA-BAB Campus, Floridablanca, Pampanga 3 = security guards (12 hrs duty/day)
- d) PhilSCA-Palmayo Campus, Pampanga
- 4 = security guards (12 hrs duty/day)
- e) PhilSCA-MBEAB Campus, Mactan, Cebu 4 = security guards (12 hrs duty/day)
- f) PhilSCA-Medellin Campus, Cebu 3 = security guards (12 hrs duty/day)

- b) PhilSCA-FAB Campus, Lipa, Batangas City = 2 units of High Capacity Caliber 9mm Pistol with extra magazine
- c) PhilSCA-BAB Campus and Palmayo Campus, Pampanga
- = 1 unit of 12 gauge box magazine feed shotgun with two extra magazine per unit
- = 2 units of High Capacity Caliber 9mm Pistol with extra magazine per unit
- d) PhilSCA-MBEAB and PhilSCA Campus, Cebu

- = 1 units of High Capacity Caliber 9mm Pistol with extra magazine per unit
- d) PhilSCA-MBEAB and PhilSCA Campus, Cebu = 1 unit of 12 gauge box magazine feed shotgun with two extra magazine per unit
- = 3 units of High Capacity Caliber 9mm Pistol with extra magazine per unit



- 7. Discussions during the pre-bid conference/additional information/reminders to the bidders:
 - a. The BAC secretariat read the Terms of Reference and the items listed in the checklist and other requirements that must be submitted by the bidders. He also informed the bidders that duplicate copies must be properly signed (wet signature) by the authorized representatives.
 - b. The BAC, through the Vice-Chair, informed/instructed the bidders that during Saturdays, Sundays, and holidays (special or regular) only five (5) security personnel are required to be deployed in the Main Campus- Pasay City per shift. She made it clear that per shift, there is one Detachment Commander and four (4) security guards. It was also added that there must be at least one security personnel who is well trained in handling CCTV operations for the VAB Campus.
 - c. For PhilSCA FAB Campus and Palmayo Campus, each campus shall have only one (1) unit of High Capacity Caliber 9mm pistol with extra magazine. Dr. Yago, the BAC Vice Chair, added that for Close Circuit Camera System, the winning bidder shall provide 2 units of 32 inches monitor and two (2) units of DVR with 32 channels.
 - d. Discussion was made with regards to the factor that will be used for the computation of No. of working days per year and it was made clear by Dr. Yago that the factor to be used is 394.40. Bidders are hereby instructed to use 394.40 for their bid computation.
 - e. It was also discussed that for PhilHealth contributions, the bidders are instructed to follow/use the 2022 rate.
 - f. The BAC informed and instructed the bidders that the admin cost must not be lower than 20% of their bid (or the contract cost). Dr. Yago reiterated that bidders will be automatically disqualified if their admin cost is found to be lower than 20% of their bid (or contract cost).
 - g. Also, the BAC clarified that the list of On-going Projects must be supported with relevant documents such as NOA, Contract Agreement, NTP, etc.
 - h. Monthly Disposition Report to SOSIA as the supporting document to show the bidder's number of guards will be considered.
 - i. The BAC instructed the bidders to use the latest PADPAO of each region applicable to the location of each PhilSCA campus.
 - j. The BAC clarified that the Security Plan required to be submitted by the bidder is only for Villamor, Pasay Campus only. Updated clearances or proof of remittances is dated January 2023 to April 2023. The bidders are instructed to provide only the list of their resources (no. of licensed firearms, number and kind of communication devices, number and kind of motorpowered vehicles, number of licensed guards). Supporting documents will be verified during the post-qualification activities.
 - k. Bidders are required to conduct ocular inspection only for the Villamor Campus, Pasay City for the Security Plan preparation.



- It was reiterated to the bidders that all pages of submitted documents must be properly signed by the authorized representative signifying that the document is a true copy of the original.
- m. Bidders are not required to include the *flashdrive* inside their bid envelope, but requested to hand carried it during the opening of bids which will be used for presentation purposes.
- n. The BAC required the bidders to have a regional office available for each region where PhilSCA Campuses are located. The bidder requested the BAC to consider that during the opening of bids, bidders are allowed to submit their certificate of undertaking that they will provide/set up a regional office in case they are declared as the winning bidder. However, the BAC did not consider the request. Another bidder requested to waive the requirement of having a regional office particularly in Batangas considering that is considerably near from the NCR. However, the BAC reiterated that bidders must have their regional office in Batangas.

This Supplemental Bid Bulletin No. 2 shall form part of the Bid Documents. Any provision in the Bid Documents inconsistent herewith is hereby amended, modified, and superseded accordingly.
