RESOLUTION OF THE PHILSCA BIDS AND AWARDS COMMITTEE DECLARING STARCOM MANPOWER & ALLIED SERVICES, INC. AS THE BIDDER WITH THE LOWEST CALCULATED AND RESPONSIVE BID FOR THE REBIBBING FOR THE PROCUREMENT OF JANITORIAL AND HUMAN RESOURCE SERVICES FOR THE PHILIPPINE STATE COLLEGE OF AERONAUTICS FOR THE PERIOD OF JUNE TO DECEMBER 2023 WITH A TOTAL CONTRACT PRICE EQUIVALENT TO FIVE MILLION FIVE HUNDRED SIXTY-ONE THOUSAND SIX HUNDRED THIRTY-FOUR PESOS AND TWENTY-SIX CENTAVOS (PHP 5,561,634.26)

WHEREAS, the pre-procurement conference was conducted on last April 11, 2023 and the BAC agreed to adopt the same Terms of Reference used during the first bidding activities;

WHEREAS, the Invitation to Bid (ITB) for the abovementioned procurement was posted simultaneously in PhilGEPS Website (Reference No. 9704266), College website, and bulletin boards starting from April 28, 2023 to May 18, 2023;

WHEREAS, the Bids and Awards Committee issued Notice of Rescheduling of prebid conference from May 5, 2023 to May 8, 2023 because majority of its members were required to attend Training Order No. 21, s2023 on May 5 – 6, 2023. The same notice was posted in the PhilGEPS and College website and in the bulletin board;

WHEREAS, in response to the advertisement, there are five (5) prospective bidders attended the online pre-bid conference held last May 8, 2023. There were several changes/corrections in the TOR and the secretariat was instructed to reflect them in the issuance of bid bulletin;

1. GFR Manpower and Janitorial Services Corporation;
2. Starcom Manpower & Allied Services;
3. RCL Cleaners Services Corporation;
4. D'Triumph Cleaners and Allied Services; and
5. VISHNU Property Management Inc.

WHEREAS, Bid Bulletin No. 1 was issued last May 15, 2023 and posted at PhilGEPS and College websites, and also in the bulletin board of the Supply Office;

WHEREAS, the opening of bids was held last May 22, 2023. Bids documents from Starcom Manpower & Allied Services and D'Triumph Cleaners and Allied Services were received. The bid submitted by the two bidders passed all the eligibility, technical and financial requirements for the project. The financial envelope was opened and resulted the following:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted Starcom Manpower & Allied Services, Inc. with the Single Calculated Bid, its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To declare Starcom Manpower & Allied Services, Inc. as the Bidder with the Lowest Calculated and Responsive Bid for the Rebidding for the Procurement of Janitorial and Human Resource Services for the Philippine State College of Aeronautics for the period of June to December 2023 with a total contract price equivalent to Five Million Five Hundred Sixty-One Thousand Six Hundred Thirty-Four Pesos and Twenty-Six Centavos (PhP5,561,634.26); and
- To declare Starcom Manpower & Allied Services, Inc. as the winning bidder for the Rebidding for the Procurement of Janitorial and Human Resource Services for the Philippine State College of Aeronautics for the period of June to December 2023 with a total contract price equivalent to Five Million Five Hundred Sixty-One Thousand Six Hundred Thirty-Four Pesos and Twenty-Six Centavos (PhP5,561,634.26).
