



**REBIDDING FOR THE PROCUREMENT OF JANITORIAL AND HUMAN RESOURCES
 SERVICES FOR THE PHILIPPINE STATE COLLEGE OF AERONAUTICS
 FOR THE PERIOD OF JUNE TO DECEMBER 2023**

CONTRACT AGREEMENT

This CONTRACT made and executed this 15th day of June 2023 between the **PHILIPPINE STATE COLLEGE OF AERONAUTICS** of the Philippine (hereinafter called "the Entity") of the one part and **STARCOM MANPOWER AND ALLIED SERVICES** of Quezon City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly janitorial services and human resource services and has accepted a Bid by the Supplier for the supply of goods and services in the sum of **Five Million Five Hundred Six One Thousand Six Hundred Thirty Four Pesos and Twenty Six Centavos, PhP 5,561,634.26** only (hereinafter called the "Contract Price");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expression shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- (a) Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletin,
- (b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- (c) Performance Security;
- (d) Notice of Award of Contract; and the Bidder's conforme thereto; and

3. In consideration of the Five Million Five Hundred Six One Thousand Six Hundred Thirty-Four Pesos and Twenty-Six Centavos, PhP 5,561,634.26 or such other sums as may be ascertained, Starcom Manpower and Allied Services, Inc. to deliver and perform janitorial and human resource services in accordance with his/her/its Bid.
4. The Philippine State College of Aeronautics agrees to pay the above-mentioned sum in accordance with the terms of the bidding.
