TERMS OF REFERENCE

I. NAME OF PROJECT

This project will be known as OUTSOURCING OF COMMERCIAL PILOT LICENSE FLIGHT AND GROUND TRAINING FOR THIRTY-SIX (36) BACHELOR OF SCIENCE IN AIR TRANSPORTATION STUDENTS.

II. PROJECT REQUIREMENTS

This project will cover CPL GROUND AND FLIGHT TRAINING that will be received by the BSAT students of Philippine State College of Aeronautics-Flying School the declared ender user. Any company who will be able to comply with the requirements and recognized by the Bids and Awards committee after the due process of bidding shall be declared as the supplier or training provider.

A. PROJECT / TRAINING REQUIREMENTS AND DETAILS:

- a. Training Specifications
- 1. CPL Advanced Ground Training and Flight Training (ATAM 4103, ATAM 4104) must cover all the minimum applicable requirements stipulated in the PCAR Part 2.3 for Commercial Pilot License and PhilSCA BSAT Curriculum.
- 2. Training provider shall cover minimum required insurance of the student trainees during the conduct of the CPL training.
- 3. Training provider shall assist the students in securing permits and licenses applicable to the training.
- 4. The training provider shall have the capacity to accommodate 60 -70 students per semester.

- b. Fleet and Training Resources Requirements
- 1. The training provider shall have at least five (5) single reciprocating engine airplane intended for CPL training.
- 2. The training provider shall have at least two (2) flight simulators to sufficiently accommodate the number of trainees.
- c. Manpower Requirements
- 1. The training provider shall have not less than eight (8) rated ground flight instructors and at least five (5) flight training instructors.
- d. Legal and Operational Requirements
- 1. The training provider shall be a holder of a valid and current ATOC-PS.
- There must an established safety and security procedures.
- 3. Must have an engagement with Higher Education Institution for at least five (5) years.
- 4. Company shall exist for at least three (3) years.

e. Other Requirements

- 1. The training provider shall provide the training outline and course syllabus to the PhilSCA Flying School in printed
- 2. The training provider shall provide the evaluation results and numerical grade in accordance to the College grading system and in coordination with the PhilSCA Flying School.
- 3. The training provider shall present and follow a training plan and time table to PhilSCA Flying School prior to the conduct of the training.

f. Allocated Budget for the Contract

The allocated budget for this project is thirty five million two hundred eighty thousand pesos (35,280,000 Php) inclusive of applicable taxes, 4% administrative cost and other inclusions.

g. Project Completion Period

The Philippine State College of Aeronautics – Flying School is expecting to complete the delivery of training package within TWENTY ONE (21) MONTHS after the issuance of notice to proceed.
