This Supplemental Bid Bulletin No. 1 dated July 26, 2023 is being issued to clarify, modify or amend items in the Bidding Documents.

6 Other Discussions:

- a. It was made clear that the project is a negotiated procurement consisting of two (2) lots. Bidders may join either for Lot 1 or Lot 2 only, or both the two lots. The BAC secretariat read and discussed each section of the Bidding Documents.
- c. It was discussed and allowed by the members of the Bids and Awards Committee to change the delivery period from 90 calendar days to one hundred eighty (180) calendar days upon the receipt of the Notice to Proceed. It was made clear that the winning bidder is responsible for the delivery of each aircraft in every satellite campus in Pampanga, Batangas and Cebu.
- d. It was also discussed that the familiarization training is consist of 3-day lecture and 2-day actual (hands-on) training. Also, the warranty period was reiterated up to three (3) months only.
- h. It was also discussed that no re-painting will be done on the body of each aircraft, but the supplier must ensure that the body is in good and presentable condition. No logo of the school will be painted or attached.
- j. It was made clear that the submission of bids will be done manually. It was also made clear that the bidders are requested to bring with them a flash drive containing the e-copies (scanned copies) of the documents submitted to be presented during the opening of bids. The flash drive is not an eligibility requirement.

7. Addendum:

- a. This is to inform all prospective bidders that the aircraft to be delivered are not required to apply for any insurance since the units have no current and valid air-worthiness certification.
- b. This is also to inform all prospective bidders that the submission and opening of bids is moved originally from August 1, 2023 to August 2, 2023 because the schedule of the Academic Council Meeting coincides with the original schedule of the submission and opening of bids.
