- The procurement is one (1) lot. The SLCC is within five (5) years prior to the deadline for the submission and receipt of bids.
- The delivery period is changed from 30 days to 60 days upon issuance of the NTP.
- ➤ Bidders are instructed to include supporting documents that will show compliance to each specification/requirement stated in the Bidding Documents.
- All units are to be delivered in the main campus, PhilSCA-VAB, Pasay City for inspection purposes. Also, the winning bidder will deliver one unit to MBEAB campus.
- All offers must be 2023 model or edition and must be wide body.

b. One of the bidders wanted to clarify the difference between a van and passenger van. Answer:

Based from Budget Circular No. 2022 – 1 dated February 11, 2022 on Omnibus Guidelines on the Acquisition, Use, Rental, and Replacement of Government Motor Vehicles. Based from the circular, the definition or requirement for Van and passenger van are as follow:

Passenger van: A large four-wheel enclosed vehicle intended for conveying passengers and/or hauling cargo, traditionally having four (4) doors (two side doors for the driver and front passenger, one (1) or two (2) passenger side sliding doors, and a tailgate). The seating capacity ranges from eight (8) to 18 passengers, including the driver. It has several rows of folding or removable seats behind the front passenger seat. It has no luggage compartment but an expandable area at the rear which can be used for luggage, cargoes, etc.

Van: A fully or partially enclosed four-wheel general purpose utility vehicle with two (2) compartments; (i) the front cabin/cab with two (2) side doors seating three (3) passengers, including the driver, on a full width seat, and (ii) the rear deck accommodating eight (8) to 16 passengers with facing collapsible bench seats accessible is considered a van.

b. The Bidders are instructed to provide a *flash drive* containing the scanned copies of their documents submitted during the opening of bids but it was made clear that the flash drive is not an eligibility requirement.

This Supplemental Bid Bulletin No. 2 shall form part of the Bid Documents. Any provision in the Bid Documents inconsistent herewith is hereby amended, modified, and superseded accordingly.
