WHEREAS, Mr. Kenneth Camyr M. Mindajao, Budget Officer, issued Certification No. PSCABO-2022-09-164 dated September 8, 2022 certifying that there is budget allocation for the project under Internally Generated Fund with an ABC equivalent to Five Million Five Hundred Thousand Pesos, PhP 5,500,000.00);

WHEREAS, the project is included in theAPP 2022 of the Collegeunder the Information and Communication Technology Equipment;

WHEREAS, the Bids and Awards Committee together with its Technical Working Group, conducted their pre-procurement conference last August 23, 2023 where they reviewed and approved the Terms of Reference and the Technical Specifications of the project;

WHEREAS, the Invitation to Bid (ITB) for the abovementioned procurement was posted/advertised in the Supply Office Bulletin Board, College’s website, PhilGEPS Website with Reference No. 10074680startingfrom August 25, 2023 to September 14, 2023;

WHEREAS, in response to the advertisement, only the representative from GABIGROUP Inc. attended and participated the pre-bid conference held last September 6, 2023;

WHEREAS, Bid Bulletin No. 1 was issued and posted in the College and PhilGEPS websites, and in the Bulletin Board last September 4, 2023 to inform and notify all prospective bidders that the schedule of pre-bid conference was moved from September 1, 2023 to September 6, 2023 due to work cancellation in the NCR;

WHEREAS, Bid Bulletin No. 2 was issued and posted in the College and PhilGEPS websites, and in the Bulletin Board last September 12, 2023. Bid Bulletin No.2 contains the modifications made during the pre-bidconference and reiterating that the submission and opening of bids were moved to September 19, 2023;

WHEREAS,the opening of bids was conducted lastSeptember 19, 2023.The bid documents submitted byGABIGROUP Inc., the lone bidder, passed the all eligibility, technical and financial requirements stated in the Bidding Documents.The opening of bids resulted the following:


