TERMS OF REFERENCE

I. PROJECT DESCRIPTION:

The Philippine State College of Aeronautics (PhilSCA) requires to engage the services of a consultancy firm to handle the construction supervision and project management of the Construction of a Sewage Treatment Plant(STP) with Site Development in the Philippine State College of Aeronautics-Villamor Campus in accordance to the guidelines specified in Annex H of the revised 2016 IRR of RA 9184. The said project is located in Piccio Garden, Villamor, Pasay City, NCR with an approved budget for contract of three hundred thousand pesos only (Php 300,000.00).

This Terms of Reference conveys the Scope of Services required from the consultancy firm, herein referred to as the "Consultant."

II. OBJECTIVES

- PhilSCA necessitates a qualified local consultancy firm with expertise in architectural, structural, electrical, mechanical, sanitary, plumbing and electronic designs for the Infrastructure project.
- The Consultant shall likewise provide support services for the College to decide on the bid most advantageous to the national government.

III. SCOPE OF SERVICE

A. Construction Supervision

The Consultant shall perform the following supervisory functions:

- Inspection and expediting of works;
- Verification and checking of quantities and qualities of work accomplished by the contractor as against the approved plans, specifications and program of work;
- Issuance of instructions for corrections or defects on the work;
- Verification and recommendation for approval of statements of work accomplished, and certificate of project completion by the contractor;
- Review and recommendation for approval of progress and final billings of the contractor; and
- Provision of record or as-built drawings of the completed project.

B. Project Management

The Consultant shall perform the following project management functions:

- Procurement advisory services;
- Monitoring and;
- Post-evaluation services.

The Principal/Lead Architect as the Team Leader must be a registered and licensed Architect with at least ten (10) years of relevant experience. Must be an active member of the United Architects of the Philippines (UAP) or the Accredited and Integrated Professional Organization for Architects (AIPOA).

The Junior Architect must be a registered and licensed Architect with at least five (5) years of relevant experience.

The Civil Engineer/Sanitary Engineer must be registered and licensed with at least five (5) years of relevant experience.

The File Custodian must be a college graduate with Accountancy background and with at least three (3) years of relevant experience.

V. APPROVED BUDGET FOR THE CONTRACT:
Three hundred thousand pesos only (Php300,000.00).
