

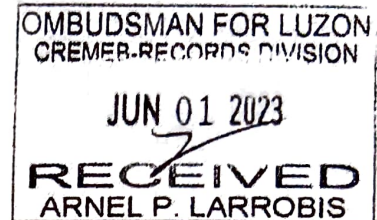

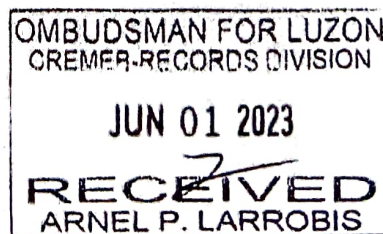
## TRANSMITTAL LETTER

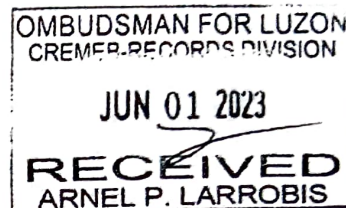
## **CERTIFICATION OF COMPLIANCE**
