**RESOLUTION OF THE PHILSCA BIDS AND AWARDS COMMITTEE RECOMMENDING TO AWARD THE CONTRACT FOR THE REBIDDING OF THE REPAIR AND REHABILITATION OF WATER LINE SYSTEM OF PHILSCA VILLAMOR CAMPUS TO TARLAC 3-G CONSTRUCTION AND DEVELOPMENT CORPORATION WITH A CONTRACT PRICE EQUIVALENT TO FIVE MILLION EIGHT HUNDRED EIGHTY-EIGHT THOUSAND EIGHT HUNDRED EIGHTY-EIGHT PESOS AND EIGHTY-EIGHT CENTAVOS (PHP 5,888,888.88) AND RECOMMENDING THE APPROVAL FOR THE FOREGOING FINDINGS OF THE BIDDING ACTIVITIES**




