**REBIDDING OF THE REPAIR AND REHABILITATION OF WATER LINE SYSTEM

CONTRACT AGREEMENT

THIS AGREEMENT, made this 15th day of January, 2024 between the **PHILIPPINE STATE COLLEGE OF AERONAUTICS**, Picco Garden, Villamor, Pasay City (hereinafter called the "Entity") and **TARLAC 3G CONSTRUCTION AND DEVELOPMENT CORPORATION**, 089 Calius St., San Vicente, Conception, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Rebidding of the Repair and Rehabilitation of Water Line System of PhilSCA Villamor Campus /PB2023 – Infra - 27** (hereinafter called "the Works") and the Entity has accepted the Bid for **Five Million Eight Hundred Eighty-Eight Thousand Eight Hundred Eighty-Eight Pesos and Eighty-Eight Centavos (PhP 5,888,888.88)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Five Million Eight Hundred Eighty-Eight Thousand Eight Hundred Eighty-Eight Pesos and Eighty-Eight Centavos (PhP 5,888,888.88)** or such other sums as may be ascertained, **Tarlac 3-G Construction and Development Corporation**, agrees to deliver and execute the contract in accordance with his/her/its Bid.
4. The **Philippine State College of Aeronautics**, agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The **Tarlac 3-G Construction and Development Corporation** must pay **PhilSCA** liquidated damages, not by way of penalty, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods or services scheduled for delivery or performance for every day of delay. The liquidated damages will be imposed until such goods or services are finally delivered or performed and accepted by **PhilSCA**.


