WHEREAS, in connection to the approval of BAC Resolution No. 46A-2024, AVLS All Visual & Lights System Corp. was declared as the winning bidder with the Single Calculated and Responsive Bid for the Rehabilitation of Speech Laboratory of the Philippine State College of Aeronautics/Rebidding for the Supply, Delivery, Installation and Commissioning of Digital Speech Laboratory including Fixtures in the amount equivalent to Nine Million Three Hundred Twenty Thousand One Hundred Sixty Pesos (PhP 9,320,160.00) only;
