CONTRACT AGREEMENT

**Supply, Delivery and Installation of Scientific and Technical Equipment
of Aeronautical Laboratory (Fully Functional Wind Tunnel with Accessories) for the
Institute of Engineering and Technology – Philippine State College of Aeronautics**

THIS AGREEMENT made on 24th day of May 2024 between the **PHILIPPINE STATE COLLEGE OF AERONAUTICS** (hereinafter called “the Entity”) of the one part and **MILTRADE INDUSTRIAL SALES INC.**(hereinafter called “the Supplier”) of the other part.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **SUPPLY, DELIVERY AND INSTALLATION OF SCIENTIFIC AND TECHNICAL EQUIPMENT OF AERONAUTICAL LABORATORY (FULLY FUNCTIONAL WIND TUNNEL WITH ACCESSORIES) FOR THE INSTITUTE OF ENGINEERING AND TECHNOLOGY – PHILIPPINE STATE COLLEGE OF AERONAUTICS** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWENTY – FOUR MILLION NINE HUNDRED THIRTY - SEVEN THOUSAND PESOS (PHP 24,937,000.00)**(hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - a. Schedule of Requirements;
 - b. Technical Specifications;
 - c. General and Special Conditions of Contract; and
 - d. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;



- iii. Performance Security
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **TWENTY – FOUR MILLION NINE HUNDRED THIRTY - SEVEN THOUSAND PESOS (PHP 24,937,000.00)** or such other sums as may be ascertained, **MILTRADE INDUSTRIAL SALES INC.** agrees to deliver the goods and services in accordance with his/her/its Bid.
4. The **PHILIPPINE STATE COLLEGE OF AERONAUTICS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The **MILTRADE INDUSTRIAL SALES INC.** must pay **PhilSCA** liquidated damages, not by way of penalty, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods or services scheduled for delivery or performance for every day of delay. The liquidated damages will be imposed until such goods or services are finally delivered or performed and accepted by **PhilSCA**.
