CONTRACT AGREEMENT

Procurement of Various Licensed IT Software Applications for PhilSCA (Consists of Two Lots)

Lot 2: Procurement of PhilSCA License Operating System

THIS AGREEMENT made on 12th day of July 2024 between the **PHILIPPINE STATE COLLEGE OF AERONAUTICS** (hereinafter called "the Entity") of the one part and **DCI INT'L I.T. SOLUTIONS & SERVICES CORP.** (hereinafter called "the Supplier") of the other part.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Procurement of PhilSCA License Operating System** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION THREE HUNDRED FORTY - ONE THOUSAND ONE HUNDRED FIFTY PESOS (PhP 1,341,150.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - Philippine Bidding Documents (PBDs);
 - a. Schedule of Requirements;
 - b. Technical Specifications;
 - c. General and Special Conditions of Contract; and
 - d. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- Notice of Award of Contract; and the Bidder's conforme thereto; and iv.
- Other contract documents that may be required by existing laws and/or the ٧. Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of One Million Three Hundred Forty One Thousand One Hundred Fifty Pesos (PhP 1,341,150.00) or such other sums as may be ascertained, DCI Int'l I.T. Solutions & Services Corp. agrees to deliver the goods and services in accordance with his/her/its Bid.
- 4. The PHILIPPINE STATE COLLEGE OF AERONAUTICS agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
- 5. The DCI Int'l I.T. Solutions & Services Corp. must pay PhilSCA liquidated damages, not by way of penalty, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods or services scheduled for delivery or performance for every day of delay. The liquidated damages will be imposed until such goods or services are finally delivered or performed and accepted by PhilSCA.
