RESOLUTION OF THE PHILSCA BIDS AND AWARDS COMMITTEE RECOMMENDING TO AWARD THE CONTRACT FOR THE AIRCRAFT ENGINE OVERHAUL (PARTS AND LABOR) TO PEGASUS AIR SERVICES, INC. WHEREAS, BAC Resolution No. 104 – 2025 declared Pegasus Air Services, Inc. as the winning bidder with the Single Calculated and Responsive Bid for the Aircraft Engine Overhaul (Parts and Labor) in the amount equivalent to Five Million Four Hundred Ninety-Nine Thousand Nine Hundred Ninety-Nine Pesos and Ninety-Eight Centavos (PhP 5,499,999.98) only;
